Abstract

Additions, documenting the basic administrative activities of the WBVTAE (now known as the Wisconsin Technical College System Board), established in 1911 and charged with the establishment and administration of policy for the vocational, technical and adult education programs of the state. Initially named the State Board of Education, the agency became the State Board of Vocational Education in 1917 and, in 1937, the State Board of Vocational and Adult Education. Later, in 1965, it was renamed the Board of Vocational, Technical and Adult Education. The Board took on its current name in 1993.

These additions, consisting primarily of routine operational and planning records, include Director's speeches, addresses, editorials, articles, and radio scripts; federal funds use plans and recommendations; district vocational education activities plans; policy and planning worksheets and subject files; commission working papers and background materials; and biennial budget requests. Adding further substance and historical context to an already sizable substantial body of WBVTAE records and publications, these papers address executive direction and mission communication; rudimentary policy, planning and budgeting guidelines; federal grant application and allocation; vocational education and special services delivery planning; apprenticeship and technical education procurement; and the work of the Governor's Commission for a Quality Workforce (1989-1990).
